## How To Get Compact Privileges

### A STEP-BY-STEP PROCESS OF HOW TO OBTAIN COMPACT PRIVILEGES TO PRACTICE/WORK IN COMPACT MEMBER STATES

1. First, determine if you meet ALL the eligibility criteria to apply for and obtain and maintain compact privileges:

- i. You need to hold a current, valid PT or PTA license in your home state of residence, which must be actively issuing and accepting compact privileges. ([See map of compact states.](#))
- ii. You must have a valid driver's license proving permanent residency in your home state. ([Flexibility for active duty military and their spouses only](#))
- iii. You cannot have any active encumbrances or any disciplinary action against any license for a period of at least two years.
- iv. The state where you are seeking a compact privilege must be a member of the PT Compact and actively issuing and accepting compact privileges. ([See map of compact states.](#))

2. If you meet all criteria, then you should determine the compact privilege fees and jurisprudence requirements for each state you want to obtain a privilege in. For most states, you must successfully take and pass the jurisprudence requirement/exam for each state you want a compact privilege in before applying for compact privileges. Not all states require a jurisprudence exam, however, if you fail to take and pass the state jurisprudence when required you may face disciplinary action.

I understand that I am only eligible for a Compact Privilege if I hold a license to practice as a physical therapist/work as a physical therapist assistant in my Home State, as that is defined in the Physical Therapy Licensure Compact. If I mislead the Physical Therapy Licensure Compact Commission about my Home State, the appropriate physical therapy board may take action against my Compact Privilege, which will result in the immediate revocation of all other Compact Privileges I may hold. I will also be prohibited from obtaining any other Compact Privileges for a period of at least two (2) years.

- I attest that I will comply with the laws and rules governing the practice of physical therapy in any jurisdiction in which I practice with a Compact Privilege. \*

I understand that the issuance of a Compact Privilege authorizes me to legally practice as a physical therapist/work as a physical therapist assistant in the member jurisdiction in accordance with the laws and rules governing physical therapy in that jurisdiction. If I violate the physical therapy practice act, the appropriate physical therapy board may take action against my Compact Privilege, which will result in the immediate revocation of all other Compact Privileges I may hold. I will also be prohibited from obtaining any other Compact Privileges for a period of at least two (2) years.

- I attest that I completed the jurisprudence requirement for the jurisdiction(s) in which I am obtaining a Compact Privilege. \*

The jurisdiction(s) in which I am obtaining a Compact Privilege require me to complete a jurisprudence requirement before the issuance of the Compact Privilege. If the board determines that I did not meet the jurisprudence requirement prior to the issuance of the Compact Privilege, the Board will take action to remove my Compact Privilege, which will result in the immediate revocation of all other Compact Privileges I may hold. I will also be prohibited from obtaining any other Compact Privileges for a period of at least two (2) years.

- I attest that I will complete the jurisprudence requirement within thirty (30) days of the issuance of my Compact Privilege. \*

The jurisdiction(s) in which I am obtaining a Compact Privilege require me to complete a jurisprudence requirement within thirty (30) days of the issuance of the Compact Privilege. If the board determines that I did not meet the jurisprudence requirement within 30 days of the issuance of the Compact Privilege, the Board will take action to remove my Compact Privilege, which will result in the immediate revocation of all other Compact Privileges I may hold.
